## A. About the document

The following is a log of banned entities by Textile Exchange. Each ban has been assigned a unique number for easy reference. This can be found at the top left corner, before the banned entity name (for example, “Ban 15”). Please note that not all numbers will be listed nor listed sequentially due to some bans having been appealed, expired, or are still pending review/approval.

**NOTE:** Bans with an asterisk where a number would be (for example, “Ban \*\*”) have not been assigned a number in our system yet but will be assigned one within 2026.

Entities listed in Section 1 have been banned from becoming certified to or licensed for Textile Exchange standards. Please refer to the “expiry” and “status” columns for more details related to each ban. Bans are issued in cases where there is a gross violation of requirements or fraudulent activity by either certified or non-certified organizations, and/or by non-licensed entities, and may be issued in other cases where other risks are identified by Textile Exchange.

Entities listed in Section 2 are for farms that have received an automatic 180-day ban from RDS, RWS, RMS, or RAS certification due to critical non-conformities. Only the TE-ID of these farms has been provided for confidentiality purposes.
